

- 1. This refers to the agreements during the Economic Development Committee Meeting conducted on September 6, 2018 related to the preparation of the CY 2020 Annual investment Program and the ensuing preparation of the FY 2020 Budget Proposals to commence next year.
- 2. It may be recalled that RDC XI passed Resolution No. 81, series of 2015, "Urging the National Government Agencies to Allocate at Least 1% of their Budgets for Indigenous Peoples (IPs) Programs and Projects" (attached), in view of the need to establish the means for the full economic, social and cultural development and empowerment of the IPs.
- 3. To fully implement the said Resolution, the National Commission on Indigenous Peoples (NCIP) XI presented a set of Guidelines/Mechanism for the implementation of the 1% Agencies' Budget for IP Programs and Projects, which was consequently adopted by the RDC XI through Resolution No. 15, series of 2018.
- 4. In view of the foregoing, this is to provide you with the said Resolution and the NCIP XI Guidelines/Mechanism for the implementation of the 1% Agencies' Budget for IP Programs and Projects, which also contains the different thematic issues faced by the IPs in the Region and proposed actions to address the same, for your reference and guidance in proposing Programs, activities and projects for succeeding Investment Programming and Budgeting exercises.

RDC XI Resolution No. 15, Series of 2018

ADOPTING THE MECHANISM FOR THE IMPLEMENTATION OF THE ONE PERCENT (1%) BUDGET FOR INDIGENOUS PEOPLES PROGRAMS AND PROJECTS

WHEREAS, the Indigenous Peoples (IPs) are considered as among the vulnerable sectors in society who need the prime attention of government, hence, this Council found it appropriate that the IPs be given priority in government services with the provision of regular fund support through programs and projects dedicated to the IPs, as embodied in Resolution No. 81, s. 2015, urging the national government agencies (NGAs) to allocate at least one percent (1%) of their respective annual budgets for programs and projects for the IPs, issued on December 15, 2015;

WHEREAS, the integration of the 1% allocation for IP programs and projects was being monitored by the Council through their submission of annual investment programs (AIPs) and during the conduct of RDC XI budget review and consultation;

WHEREAS, there is no clear mechanism on the implementation of the subject 1% allocation which resulted in the identification of IP programs and projects without consultation from the IP communities in the region, most of which are by attribution;

WHEREAS, the National Commission on Indigenous Peoples (NCIP) XI prepared a proposed mechanism to facilitate the implementation of the 1% budget for IP programs and projects, which was presented to and favorably endorsed by the Social Development Committee XI during its meeting on March 12, 2018;

WHEREAS, this Council finds the proposed mechanism appropriate for the implementation of the 1% agency budget for IP programs and project (Annex A);

NOW, THEREFORE, BE IT, RESOLVED, AS IT IS HEREBY RESOLVED, that this Council adopt the proposed mechanism on the implementation of the one percent (1%) budget for IP programs and projects.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the National Commission on Indigenous Peoples XI, for information and appropriate action.

Proposed Guideline/Mechanism for the Implementation of the One Percent (1%) Agencies Budget for IP Programs and Projects per RDC XI Resolution No. 81, s. 2015

Planning and Budgeting Process

- a) The basis of the projects to be funded is the community ADSDPP or the NCIP Regional Master Plan where priority projects from the ADSDPPs/IPCDP are consolidated;
- b) Prior to the scheduled planning and budgeting, NCIP XI shall conduct planning workshop with IP leaders (IPMRs and AD representatives) to prioritize projects to be funded for the ensuing year (site selection/prioritization will be done in this process);
- c) As a result of the planning workshop, NCIP XI will come up with annual investment plan (AIP) clustered per agency concerns to be submitted to the agencies prior to planning and budgeting (DA, DOH, DENR, DSWD, OPAPP, among others) possibly with project proposals or project brief.
- d) The AIP matrix shall include a column that would provide information on the recognized IPO and IP leaders-contact persons in the community;
- e) Project tagging is proposed containing the following information: No. of CADTs, No. of ADSDPPs, per Province/Municipality, per IP Group;
- f) The AIP shall be endorsed by the NCIP XI Regional Director to the concerned offices, copy furnished RDC XI with Certification of the recognized IPO containing the names of the IP leaders-Non-negotiable requirement; and
- g) All government agencies is requested to provide their calendar of planning and budgeting cycle to NCIP XI for their reference.

Project Implementation

- a) Concerned agencies shall provide the RDC XI and NCIP XI with the list of approved PAPs; and
- b) Implementation of the PAPs shall be coordinated with NCIP XI Regional and Provincial Offices, IPO and IP Leaders.

Project Monitoring

- a) Report on the status of implementation of approved and funded PAPs shall be submitted by the agencies to RDC XI and NCIP XI Regional Office;
- b) The government agencies may report it compliance to RDC XI Resolution No. 81, s. 2015 during the NCIP XI funded Regional or Provincial Ulat ng Katutubo; and
- c) Meeting may be conducted to monitor progress/status of implementation, especially in areas where conflicts arise in the course of project implementation.

Guidelines/Mechanism for the Implementation of the One Percent (1%) Agencies Budget for IP Programs and Projects per RDC Resolution 81, Series of 2015

L BACKGROUND

The State recognizes the rights of the Indigenous Cultural Communities/Indigenous Peoples as enumerated in Section 2 of the Indigenous Peoples Rights Act (IPRA) within the framework of the Constitution. The ICCs/TPs are considered among the vulnerable sectors in the society that needs prime attention of the government.

In December 15, 2015, the Regional Development Council of Davao Region signed Resolution No. 81, series of 2015 urging the National Government Agencies to allocate atleast one percent (1%) of their budgets for indigenous peoples programs and projects to establish the means for the full economic, social and cultural development and empowerment of the IPs so that they become productive members of the community.

The National Commission on Indigenous Peoples (NCIP) as the primary government agency mandated to protect and promote the interest and well-being of the ICCs/IPs with due regard to their beliefs, customs, traditions and institutions presented RDC Resolution No. 81, series of 2015 to the IP leaders and consultation was done for the guidelines on the implementation of the said Resolution.

IL OBJECTIVES

The proposed guidelines/mechanisms aims to facilitate the implementation of RDC Resolution No. 81, series of 2015.

III. GUIDELÍNÉS/MECHANISMS

Planning and Budgeting Process

- The basis of the projects to be funded is the community ADSDPP or the NCIP Regional IP Master Plan where priority projects from the ADSDPPs/IPCDP are consolidated. The partner agencies may also support the NCIP flagship programs (e.g. Integrated Ancestral Domain Development Approach to Implementing Culturally Responsive Program)
- Prior to the scheduled planning and budgeting of the partner agencies, NCIP shall conduct workshop with IP leaders (IPMRs and AD Representatives) to prioritize projects to be funded for the ensuing year or NCIP shall review the ADSDPPs and cull-out the list of unfunded projects;
- As a result, NCIP will prepare the annual investment plan (AIP) clustered per agency concerns to be submitted to the agencies prior to planning and budgeting (DA, DOH, DENR, DSWD, OPAPP and others) possibly with project proposals or project brief;
- The AIP matrix shall include a column that would provide information on the recognized IPO and IP leader/s contact persons in the community;

- Project tagging is proposed containing the following information # CADT No., ADSDPP Province/Municipality, IP Group
- The AIP shall be endorsed by the NCIP Regional Director to the concerned offices copy furnished RDC XI with Certification of the Recognized IPO containing the names of IP leaders - nonnegotiable requirement
- All government agencies is requested to provide its' calendar of planning and budgeting cycle to NCIP for its reference.

Project Implementation

- Concerned agency shall provide RDC-XI and NCIP with the list of approved projects;
- Implementation of the project shall be coordinated with the NCIP Regional and Provincial Offices, IPO and IP leaders;

Project Monitoring

- Reports on the status of implementation of approved and funded PAPs shall be submitted by the agencies to RDC XI and NCIP Regional Office.
- The government agencies may report its compliance to RDC Resolution No. 81 during the NCIP funded Regional or Provincial Ulating Kannubo;
- Meeting may be conducted to monitor progress/status of project implementation especially in areas
 where conflicts arise in the course of project implementation.

IV. EFFECTIVITY

These guidelines/mechanisms shall take effect upon the adoption of the members of the Regional Development Council.

RDC XI Resolution No. 81, Series of 2015

URGING NATIONAL GOVERNMENT AGENCIES TO ALLOCATE AT LEAST ONE PERCENT (1%) OF THEIR BUDGETS FOR INDIGENOUS PEOPLES (IPs) PROGRAMS AND PROJECTS

WHEREAS, the Indigenous Peoples are considered as among the vulnerable sectors in society who need the prime attention of government.

WHEREAS, it was raised during the SDC XI 3rd Quarter Meeting that the IPs have low access to programs and services of government, stemming from observations that, specifically in the granting of scholarships, IPs have difficulty competing with thousands of applicants in view of the qualification requirements of scholarship-granting agencies resulting to very few qualified IP scholars;

WHEREAS, there is then a need to establish the means for the full economic, social and cultural development/empowerment, of the IPs so that they shall become productive members of the community;

WHEREAS, to aid in the process, strong support in terms of agency budget allocation for Government programs, services and resources is needed, similar to the allocations for gender and development, senior citizens, youth, and persons with disabilities:

WHEREAS, this Council finds it appropriate that IPs be given priority in government services with the provision of regular fund support through programs and projects dedicated to the IPs;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that this Council urge National Government Agencies (NGAs) to allocate at least one (1) percent of their respective annual budgets for programs and projects for the IPs;

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to MGAs in Davao Region, for appropriate action.

BE IT FURTHER RESOLVED, that a copy of this resolution be also forwarded to the RDCs of other regions in the country for their support/consideration.
