**MONITORING ON THE OPLAN BALIK ESKWELA AND OPENING
OF CLASSES FOR SY 2018-2019**

To: Schools Division Superintendents
Chiefs of Divisions/Units/Sections

1. The Oplan Balik Eskwela (OBE) and the Public Assistance Command Center (PACC) for SY 2018-2019 shall be activated on May 21-June 8, 2018 to ensure the smooth opening of classes and to address problems, queries and other concerns commonly encountered by the public at the start of the school year.
2. The Waling-Waling Conference Hall of the Regional Office will be turned into OBE-PACC. A help desk in the lobby with OBE tarpaulin will also be installed c/o the Supply Section.
3. A new online reporting system was introduced during the 2018 OBE national orientation. One representative from each Schools Division Office shall manage the system for the daily reports to be submitted every 11:00 AM and 4:00 PM to the Central Office. Submit the name of the representative/division focal person and the email address (preferably DepEd email address) on or before May 17, 2017 at depedxpublicaffairsunit@yahoo.com so the Central Office can register the schools division in the system.
4. The orientation for the division focal persons who will man the system will be on May 18, 2018, 1:00-5:00 PM at the ICT/Public Affairs Unit in the Regional Office.
5. Attached is the MEDIA (Monitoring Educational Developments for Immediate Action) Monitoring Report to be used which can also become the reference for the online reporting.

6. All expenses incurred during this activity, including payment for the services by the concerned personnel during the OBE, in addition to, or over and above their regular workload, shall be charged to local funds, subject to the usual accounting and auditing rules and regulations. Further, OBEIAC members who will man the help desk and Action Center during weekends are granted one-day Compensatory Overtime Credit.
